Employment assistance to the dependants of deceased/missed/disabled Armed Forces personnel- amendments in the regulations including Paramilitary Forces personnel-orders issued.

ORDER

1. As per the referred Government Order, A dependant of Armed Forces personnel killed/missed/disabled in war / warlike situation and if jawans of GREF / BSF while attached to Military killed/missed/disabled, one dependant of the jawan shall be eligible for employment assistance.
2. Government have been decided to include dependants of Keraliet who kills in harness while serving in Paramilitary Forces in the provisions of employment assistance.
3. Under this circumstance, the provisions of eligibility criteria for employment assistance referred in the above GO is amended and ordered as given below:-

“ One dependant of a person dies/missing/disables beyond any work, during discharging official duties while in service of Military and Paramilitary Forces Is eligible for employment assistance. The following are defined as Military – Paramilitary Forces”

- a) Army / Navy / Air Force.
- b) Assam Rifles (AR)
- c) Border Security Force (BSF)
- d) Central Industrial Security Force (CISF)
- e) Central Reserve Police Force (CRPF)
- f) Indo-Tibattan Border Police (ITBP)
- g) National Security Guard (NSG)
- h) Sashastra Seema Bal (SSB)

4. One dependant of GREF personnel dies / missing / disables beyond doing any work while attached to Army is eligible for employment assistance.
5. The provisions regarding employment assistance contained in the GO under reference are amended as above and ordered herewith

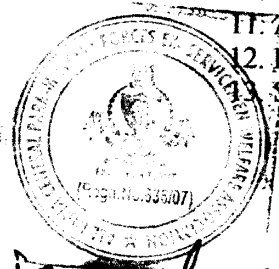
