Detailed instructions in this regard have also been finalised and are enclosed herewith for further necessary action and proper implementation of the Scheme.

SCHEME FOR EXTENDING THE EXISTING CMPF HOSPITAL FACILITIES TO THE RETIRED CPMF PERSONNEL

It has been decided to extend the existing CPMF Hospital facilities to the retired CPMF personnel, on the terms and conditions as available under CGHS.

ELIGIBILITY:

CPMF persioners who are not availing CGHS facilities will be allowed to avail medical facilities from all CPMF Hospitals irrespective of the Force they retired from. The facilities will be extended to the following categories of personnel:-

- a) CPMF pensioners and their families, the term "family" for the purpose of this benefit shall mean a CPMF pensioner's wife or husband, as the case may be, and children wholly dependent upon the Govt. servant.
 - b) Widows of CPMF personnel, getting family pension.
 - c) Child drawing pension after the CPMF employee's death and minor brothers and sisters of such child.

States which have medicare facilities under different CPMFs.

- a) <u>BSF</u>: Jammu & Kashmir, Punjab, Rajasthan, Gujrat, Mdhya Pradesh, Bihar, Karnataka, Delhi, Haryana, West Bengal and Assam.
- b) CRPF: Jammu & Kashmir, Haryana, Delhi, UP, Rajasthan, Maharastra, Gujrat, Pradesh, Kerala, Tamil Nadu, Karnataka, Orrissa, West Bengal, Bihar, MP, Manipur, Mizoram and Assam.
- c) Assam Rifles: Meghalaya, Nagaland, Manipur, Arunachal Pradesh, Tripura, Mizoram and Assam.
- d) ITBP: Himachal Pradesh, Delhi, UP, MP and Punjab.
- e) CISF: Delhi, UP, Andra Pradesh, MP, Bihar, Rajasthan and West Bengal.
- f) NSG: Delhi and Haryana.

Facilities available in CPMFs Hospitals/ 3. MI Rooms:

While at Unit level MI Rooms only primary health care facilities are available in all the CPMFs the Hospitals located at important places have diagnostic facilities like pathological laborataria Ultra sound, X-ray etc.

Since, CPMF hospitals do not have all facilities available in CGHS scheme, the proposition of CPMF hospital will have to be restricted the available facilities only, i.e. medical attend at a concerned CPMF MI Room/Hospital, supply of as prescribed by the Medical Officer of the MI Hospital and limited diagnostic and indoor page 1 facilities wherever available.
